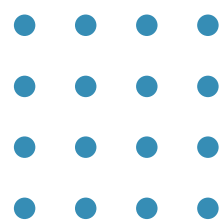


THE CRISIS WITH PREVIOUS WORKFLOW



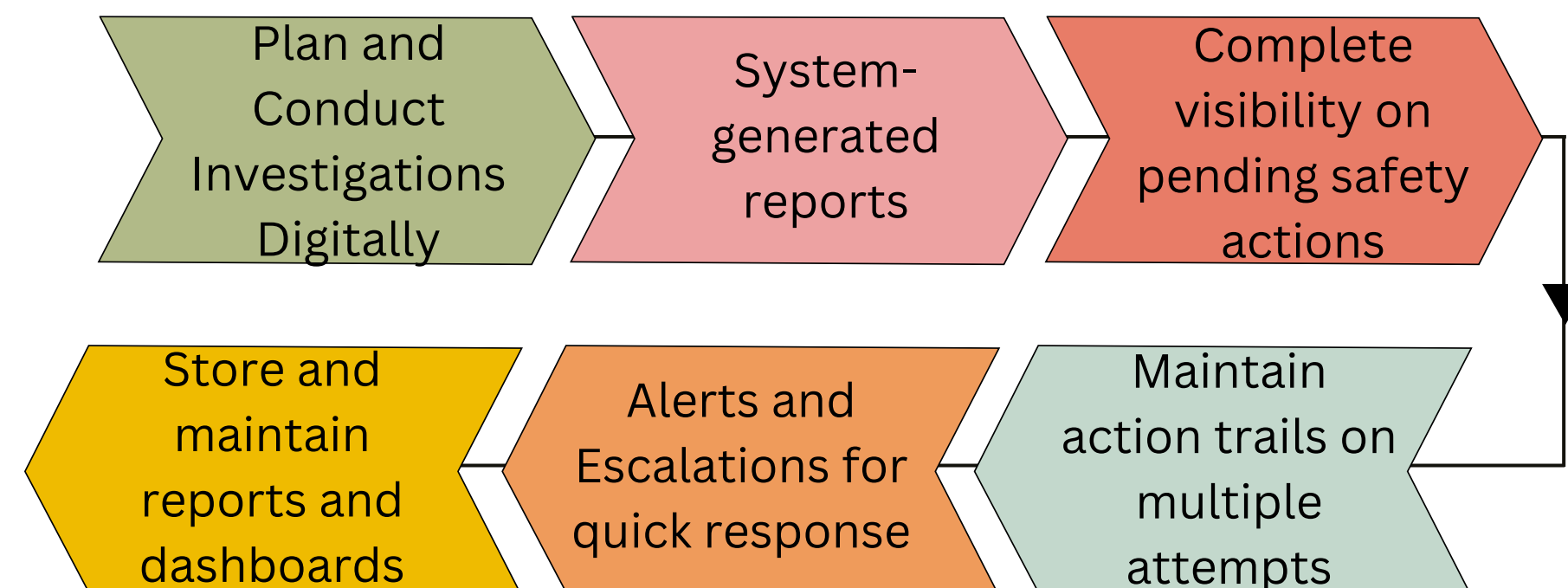

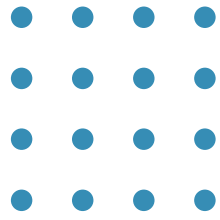
Staying ahead of Turn-around Time

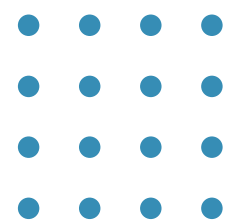

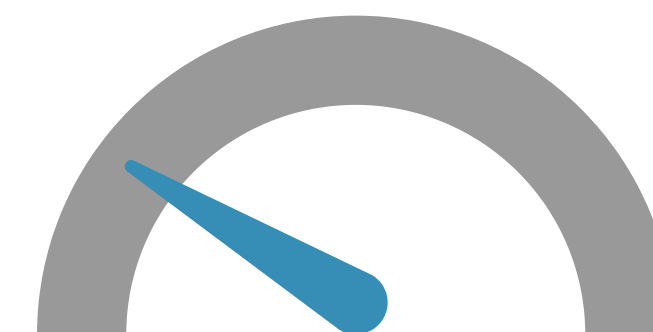
AVERAGE TIME TO CLOSE OBSERVATIONS AND INVESTIGATIONS

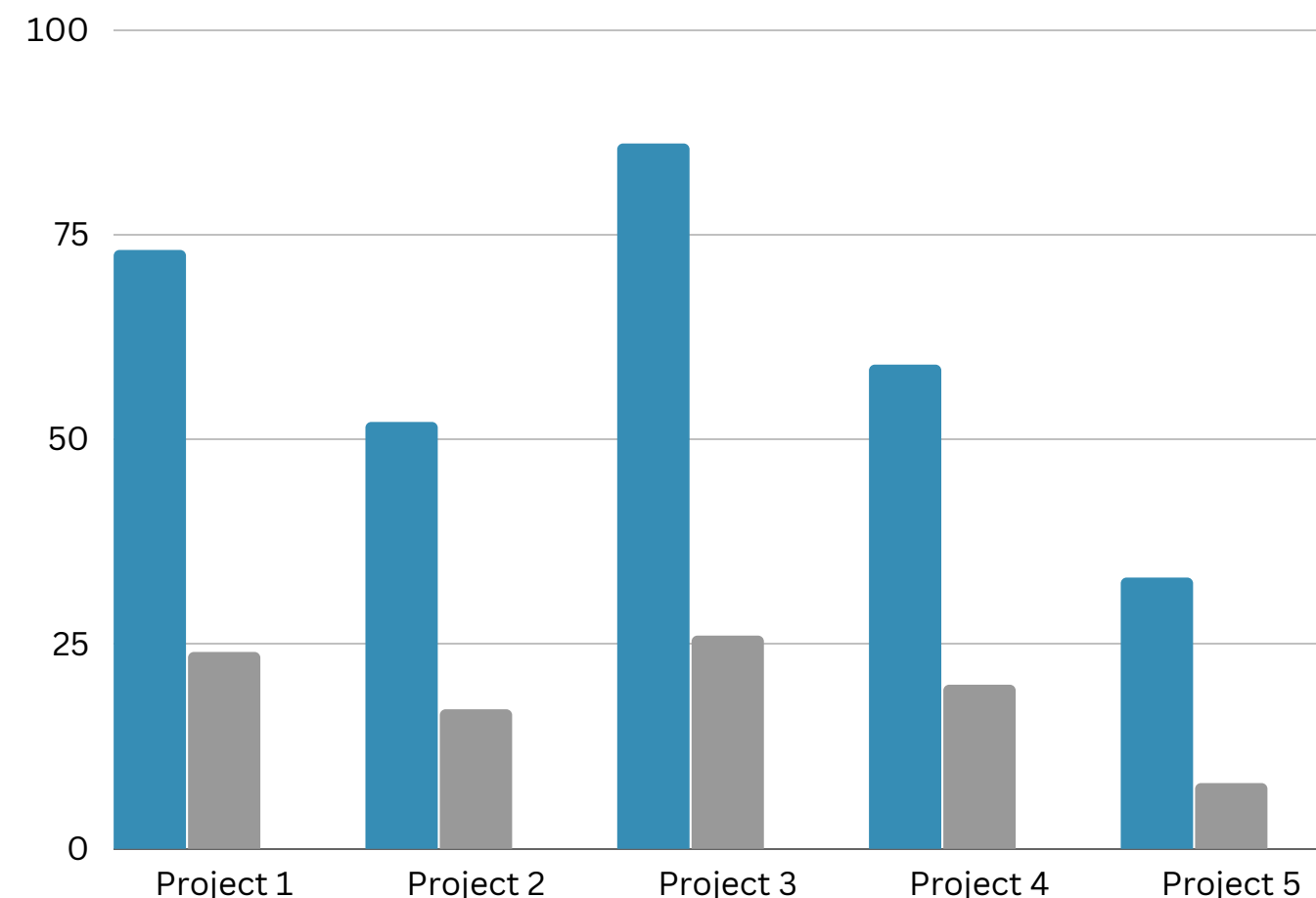

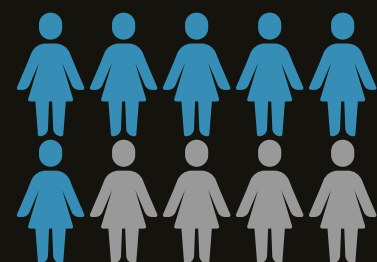
